# INTRODUCTION

COVID-19 painfully scarred 2020, indiscriminately disrupting the daily lives of people around the world. It exposed both our frailties and fractures and tested our endurance and humanity. Ultimately, it triggered profound reconsideration of our perceptions, certainties, and convictions, and brought to light unsuspected potential for adaptation, inventiveness, and solidarity in all of us.

As a part of Moroccan society, deeply permeated by its African identity, and aware of the South's expectations, the Policy Center for the New South felt compelled to take part in this ordeal, acclimatize to it, and become active in the discussion, in order to understand and analyze events and envisage potential public policy options.

Hence, we were all forced to renounce daily routines, to live, communicate, and work remotely and behind masks. Yet, despite these new constraints, we at the Policy Center, thanks to a dedicated and passionate team of people, were able to continue normal activities and broaden the scope of our written and audiovisual production to include pandemic management and its socio-economic impacts, and other social, economic, and strategic issues beyond the health crisis facing Morocco, Africa and the world.

The Center therefore focused on staying abreast of the pandemic and addressing its socio-economic impacts and fallout, its geostrategic complications, and likely scenarios for successful post-COVID recovery and management.

However, the priority interest in the pandemic did not overshadow our focus on economic and geostrategic issues facing Morocco and Africa, including developments in the areas of employment, food security, migration, and mobility, security in the Sahel and the Horn of Africa, interference in Africa and the Middle East by emerging and established powers, and global governance reform, particularly that of the United Nations, which celebrated its 75th anniversary in 2020.

Our flagship activities continued, including the 9th Atlantic Dialogues, the Annual African Peace and Security Conference (APSACO), and the Strategic Dialogues, which were held online and attracted tens of thousands of participants from over 160 countries.

The establishment on the agenda of "PCNS Tuesdays", an audiovisual weekly program on current affairs, with already 24 issues to date, was a major novelty of 2020. The other novelty was the partnership between the Policy Center for the New South, J-PAL and Evidence for Policy Design (EPoD) at the Harvard Kennedy School with the Millennium Challenge Account (MCA)to establish the Morocco Employment Lab to strengthen Moroccan scientific assessment capacity and data utilization in development of employment and labor market policies. Other ongoing communication initiatives to support the Center's interaction with the general public will be finalized in 2021.

With everyone's support and assistance, the Center's website attracted close to 530,000 visitors from 175 countries in 2020, compared to 200,000 in 2019, a 160% increase in traffic.



# **OUR AREAS** OF REFLECTION



### International Relations

This area covers key international geopolitical challenges, including defense, security, and power dynamics, with a particular focus on Africa. More specifically, it addresses the geostrategic positioning of Morocco.





### Economy

This line of research combines studies on longerterm challenges, such as structural transformation and competitiveness, with those covering macroeconomic policies at the national, regional and continental levels. It also provides broad public policy assessments.

2020 brought about a range of challenges of unprecedented magnitude. The global health crisis triggered a cascade of massive consequences, of which the world is still gradually taking stock. Economies endured severe shocks, national and international solidarities were put to the test and global equilibria shifted in ways, the effects of which remain to be seen. This fallout will be felt differently, perhaps more intensely by societies across Africa and the global South. Greater geopolitical rivalries further complicated a very grim picture, injecting added unpredictability and instability into a complicated global landscape. The successive ups and downs compounded each other as well as the sudden global economic contraction.

True to its calling and mandate, in 2020, the Policy Center for the New South, operating through its teams, rallied to inform public policy and deliberation whilst always embracing the point of view of the South. Studies of the pandemic's effects attempting to identify the economic and geopolitical implications of COVID-19, topped the list of analyses produced. From this perspective, the Policy Center chose to design a COVID-19 Program revolving around an analysis of pandemic impact on the South. In all assessments, projections and recommendations produced, we sought to identify structural trends and major paradigm shift and highlight main areas of strength, while detailing most recent developments and projecting ourselves into the near and distant future and suggesting new avenues for action and reflection.

Opinions (Blogs) provide our experts and researchers with a suitable format to decipher national and international news into short and intelligible texts. In 2020, the Policy Center for the New South's research community devoted a substantial number of Opinions to both the challenges raised by the COVID-19 pandemic as well as the political, economic and social repercussions of the global health crisis.

In these times of economic standstill and acceleration of history, the theme of unconditional universal basic income (for a limited period or an indefinite basis) strongly emerges among matters debated in economic decision-making and academic circles, North and South. In a Blog entitled "Universal Basic Income: A Response to the Coronavirus Crisis in the North and South". Larabi Jaïdi and Ivan Martin revisit the analysis of this social protection tool. They argue that a universal basic income program needs to be properly aligned with job and wage creation policies (specifically minimum wage), as well as with other basic social benefits (including education, health, pensions and unemployment insurance). The goal is to ensure that the program optimizes public resource utilization.

The COVID-19 health crisis along with the nerve-wracking issue of climate change and nagging global security situation have produced a new paradigm: major global challenges to be shouldered by all countries, both rich and developing. In a Blog entitled



"Covidonomics: the three phases of a shock", Mouhamadou Moustapha Ly examines the different potential phases that global economies will have to grapple with in the wake of the COVID-19 pandemic. The author highlights the importance of strengthening country resilience in the post-crisis period, by means of contextualized integration of the informal sector, consolidating fundamental research at universities and accelerating the digitalization of SMEs.

Morocco chose to close its air, sea and land borders to contain the spread of the COVID-19 pandemic. By ordering strict lockdown measures thereafter, authorities agreed to a partial shutdown of the economy. While these measures were necessary, some now believe that Morocco would benefit from maintaining them once the crisis has passed. In a Blog entitled "Morocco post-COVID-19: taking a bite out of globalization" Youssef El Jai focuses on the issue of opening up trade, arguing that Morocco's strategy of openness in Africa consolidated the country's position as a major continental economic player. Particularly since, according to the author, discussions held under the aegis of the African Union (AU), for the coordination of responses to the pandemic, have demonstrated the importance of multilateral cooperation for the common good.

In an opinion piece entitled "COVID-19: the advent of a divided world", Policy Center researcher Maha Skah examines the immediate consequences of the COVID-19 pandemic on major players in international relations and the resulting rebalancing of power dynamics. She notes, in view of US international disengagement and crumbling European solidarity, the preeminence of unilateralism and national responses to the current health crisis.

2020 was also a major election year at both global and continental levels. Electoral events, the outcomes of which are likely to impact current health crisis management, are at the center of crucial political, economic and security stakes for the future of countries concerned. In an Opinion piece entitled "The fall of the opposition and the emergence of new parties: an analysis of Cameroon's legislative and municipal election results", Policy Center researcher Oussama Tayebi offers a reading of the February 9, 2020 legislative and municipal election outcomes in Cameroon. The piece emphasizes the impact of this dual political reshaping on the management of the Anglophone crisis as well as on forthcoming elections in the Central African country.

The US presidential election was a highly anticipated political event in 2020, likely to signal a major shift in US foreign policy. Policy Center researcher **Souha** 



Majidi examines the impact of Joe Biden's election on the future of U.S.-Africa relations in an opinion piece entitled "What Could President-Elect Joe Biden's African Strategy Be?" The piece provides a list of priorities for the new U.S. administration and identifies measures to help strengthen U.S.-Africa relations.

Migration and mobility issues continue to be central to the dialogue between the African Union (AU) and the European Union (EU). Policy Center researchers monitored key consultations held on these issues in 2020. Policy Center researcher **Amal El Ouassif**, in an opinion piece entitled "Migration in the Post-Cotonou Agreement's Negotiations: Lessons and Future Perspectives", discusses the differences between Africa, Caribbean and Pacific (ACP) and EU member states on the issue of migration in post-Cotonou Agreement negotiations.

Policy Center researcher Hamza Mjahed, in an opinion piece entitled "The European Union's Pact on Migration and Asylum: Progress or New Setback?" examines the stakes of the European Union's new proposal for a Pact on migration and asylum. He specifically addresses the risks of tension the new strategy based on deterrence could potentially provoke in the immediate EU vicinity as well as with key African partners.

# ECONOMY

2020 will have been the year of uncertainty. The pandemic proved to be a game changer: from world economic paralysis, to unprecedented health and oil shocks and exacerbated geopolitical instability, it will have upset everything in its path. The deployment of stimulus policies will be a key component for any hope of a recovery.

### COVID-19 Program

Our Economists analyzed the global economic impact of COVID-19 in a variety of different publications.

# Economic and social fallout from COVID-19 in Africa

### Sub-Saharan Africa: from the health crisis to the oil shock

The health crisis exacerbated an already difficult economic situation for oil exporting countries of sub-Saharan Africa. Policy Center researcher Rim Berahab, in a Policy Brief entitled "African Oil Countries Facing COVID-19: Economic Challenges and Ways out of the Stalemate", analyzes the magnitude of the shock wreaked by the pandemic on largely oil-dependent economies (88% for Angola and 76% for Nigeria). Budgeted oil prices in 2020 stood respectively at \$55 and \$57 per barrel and estimated losses in African oil revenues amounted to about \$65 billion. much of which is borne by Nigeria. Furthermore, the health crisis caused other technical spill-over effects on these countries, including the postponement of oil projects, potentially risking an investment shortfall as high as \$10 billion.

### Post COVID-19: which economic policies to adopt?

The COVID-19 crisis revealed the extent to which economies are highly interdependent, vulnerable and incapable of coping with a health shock of this magnitude. This is also true for major world powers. In a Policy Brief entitled "COVID-19, what repercussions for developing countries?" Policy Center researcher Hamza Saoudi focuses on the economic and social impact of the pandemic on developing countries. He emphasizes that poorer countries in particular lack the sufficient leeway and budgetary capacity to cope with the spread of this virus. Moreover, their already fragile, and in some cases, rudimentary health systems cannot withstand sustained and increasing pressure over extended periods of time.

In a Policy Brief entitled "African Economies Post COVID-19: Beyond emotion, bold economic policies", Mr. Mustapha Ly and Fahd Azaroual recommend continued state investment to expedite the closing of the infrastructure gap, a key factor in the continent's economic growth. Employment and employability are also important levers for governments to support the new post-COVID-19 economy.



# COVID-19 Program: Survey on the attitude of Moroccans towards the pandemic

Understanding public attitudes around the Coronavirus pandemic is critical. As part of a survey conducted by the Policy Center using three rounds of polling conducted by IPSOS Morocco in June, July and September 2020, M'hammed Dreyf (Senior Fellow at the Policy Center), Dominique Guillo (Professor in Behavioral and Social Sciences at the Faculty of Governance, Economic and Social Sciences of the University Mohammed VI Polytechnic) studied the Moroccan population's perception of the COVID-19 pandemic and public policies to curb it. The survey is part of the "Attitudes towards COVID-19" research program, conducted with a consortium of international academic partners (Sciences Po, Harvard Business School and Bocconi University, among others). This program aims to benchmark data collected in 8 European countries, 7 African countries, including Morocco, as well as Brazil, Canada, the United States, Australia and New Zealand,

Analysis of the 3 rounds shows that, by the end of the lockdown, Moroccans expressed confidence in how the epidemic was being managed by medical staff and government institutions (Police and Gendarmerie) and in response measures implemented to deal with it. Moroccan citizens still



displayed relatively limited concerns over national health prospects, but did express concern over the economic impact of the pandemic. Confidence in institutions remained strong over the ensuing period (June to the second half of September 2020). However, doubts over the effectiveness of actions taken and, more broadly, concerns about the future grew as the weeks went by. This development is mirrored in other countries, with the persistence of the pandemic, and its health, economic, psychological and social effects becoming increasingly acute.

### Strengthening the Resilience of Health Systems in Africa: A New Imperative?

In a Policy Brief entitled "Health Systems in Africa Put to the Test" economist and diplomat Pierre Jacquemot focuses on the fragility of African health systems. The author argues that, based on figures, these systems are only achieving 49% of potential functionality. In the same vein, and based on data from the German health system, Mouhamadou Ly and Meriem Oudmane suggest avenues for strengthening the resilience of African health systems. In a Policy Brief, entitled "Strengthening the Resilience of Health Systems in Africa: The German Framework", the authors suggest, among other things, increasing per capita health expenditure to at least 10% of GDP per capita in the medium term, strengthening the ratios of hospital beds and health technicians per capita by 2030, and using digital technology to bridge the gap in access to specialist medical consultations.



The impact of COVID-19 on employment is far-reaching and anxiety runs high among both employees and employers. They are faced with a dilemma pitting their fear of being contaminated in the workplace against their determination to ensure business sustainability (already heavily impacted by the pandemic) and the responsibility of employers for the protection of employees. Over 4 out of 5 of the 3.3 billion people in the global workforce are affected by the total or partial closure of workplaces. In a Policy Brief entitled "The World of Work in the Age of Coronavirus: Hemorrhaging Jobs and Changing Prospects", Senior Fellow Ibourk Aomar and researchers Tayeb Ghazi and Badr Mandri analyze global labor market conditions in the light of the health crisis. Based on International Labor Office (ILO) estimates, the authors demonstrate that job losses are likely to exceed those of the 2008-09 global financial crisis, which increased the pool of the unemployed by 22 million. However, beyond its implications and current responses, the authors point out that the current pandemic provides an opportunity to improve the employment climate, particularly in developing countries. This can be done by removing barriers to the creation of decent jobs, providing better social protections for workers and promoting access to training.

### Food Security under Stress: Impacts, Responses and Legacy Challenges

A number of countries implemented population movement restrictions as containment measures to limit the spread of the virus. In light of these events, in a Policy Brief entitled: "Ensuring food security during the COVID-19 pandemic: a review of short-term responses in selected countries", Fatima Ezzahra Mengoub reviews short-term measures deployed by states to mitigate pandemic impact and effects on food security. She deems that governments have implemented a variety of measures to mitigate COVID-19 impact on food security. Furthermore, famine emergency plans remain difficult to roll-out given specific national constraints.

In addition to cyclical and ad-hoc response measures, food security hinges on a number of structural factors. In a Policy Brief entitled "Food security in the context of COVID-19: the public health challenge - the case of the republic of South Africa", Isabelle Tsakok shows that a country's food security depends essentially on its health situation. Citing the case of South Africa as an example, the author argues that food security is inextricably linked to a population's access to quality public health infrastructure.



### Impacts of the Health Crisis on the Moroccan Economy: A Preliminary Assessment

On the national level, Policy Center Executive President Karim El Aynaoui, and economists Abdelaaziz Ait Ali, Fayçal El Hossaini, and Badr Mandri provide a first detailed assessment of the health crisis' ramifications on Morocco's economy. In a Policy Paper entitled: "Impacts of COVID-19 on the Moroccan economy: a first assessment", the authors point out a severe 7 per cent contraction of economic activity, driven mainly by lockdown measures and a drastic slump in foreign demand. Regional shock dispersion is uneven and denotes a greater exposure of regions where the informal sector is important, public sector participation is low, and tourism and manufacturing activities are predominant. Simulations were conducted subjecting domestic social and macroeconomic equilibria to this recession scenario. At the social level, deep recession has a greater impact on the most vulnerable social classes, tipping some 1 million people across the poverty line and about 900 thousand others below the vulnerability threshold.

At the sectoral level, Abdelaaziz Ait Ali devotes a Policy Brief to the analysis of health crisis repercussions on the automotive industry, with particular focus on its impact on the current account. In his Paper, entitled "The National Automotive Industry in the face of COVID-19: Should we be concerned about its impact on the current account?" the author argues that despite a 40% decline in turnover for the first half of the year, the net effect of this contraction on foreign currency inflows should not be as severe. And this for two main reasons: the first relates to the sector's heavy dependence on imported inputs, thereby reducing the sector's demand for intermediate goods, and the second relates to the preponderance of foreign ownership in the sector, limiting profit repatriation outflows.

### Distance education in Morocco: Between challenges and opportunities

Education in Morocco, as elsewhere throughout the world, must now embrace distance learning alternatives. Some see this shift as a risk of deepening existing disparities in access, quality and retention. Others are taking advantage of this new experience to pave the way for innovation and the massification of quality education for all. In a Policy Paper entitled "An online school of the future, equity and quality for all: reflections around a well-designed model", Aomar Ibourk and Tayeb Ghazi analyze four components of the e-learning ecosystem, namely: access and usage conditions, parental involvement in a context of permitted or required autonomy, teacher control and interaction, and the adequacy of interfaces for effective quality teaching.

# Economic and social environment in Africa

### The Effects of Trade Policies on Economic Diversification

Economic diversification is seen as a key issue for national industrial, trade and regional policies. This is also a crucial issue in development policy debates. In a Policy Brief, entitled "Diversification and the world trading system", Uri Dadush, Abdelaaziz Ait Ali, Mohammed Al Doghan, Muhammad Bhatti, Carlos Braga, Abdulelah Darandary, Anabel González and Niclas Poitiers explore how export diversification is impacted by trade policies,



### Monetary Integration in West Africa: Issues and Challenges

In a Policy Brief entitled "Monetary Integration in West Africa: History, Theory, Policy", Policy Center researcher Youssef El Jai reviews the theoretical foundations of monetary integration in West Africa and examines the historical trajectory of monetary policy in the region. He notes that proposing the Eco as a single currency for the Economic Community of West African States (ECOWAS) is a new milestone for some countries but a simple adaptation exercise for others. The author explains that the considerations of real convergence, rules-based leadership and geopolitical risk must be addressed prior to launching the union. More importantly, countries need to be clear about desired objectives and work transparently to achieve them.

### Focus on infrastructure financing in Africa

Infrastructure investment gaps in Africa have widened over time. Addressing the mismatch between a "global savings glut" in developed countries and an "investment shortage" in African countries is potentially a win-win solution. A number of risk mitigation tools can be used to facilitate this alignment. In a Policy Brief entitled "Africa's infrastructure finance" Mahmoud Arbouch, Otaviano Canuto, and Miguel Vazquez demonstrate that by providing such risk mitigation tools, development institutions and governments can attract private investment to Africa, thereby closing the infrastructure gap essential to pave the way for continent-wide development.

### Human Security Index

As part of the Human Security Index development project initiated by an African Union (AU) resolution adopted in 2013, the Policy Center for the New South was invited to join a working group of Knowledge Partners at a consultation for the design and quantitative methods of index compilation.


The meeting held in Addis Ababa on March 5 and 6, 2020, produced an action plan, structured as follows:

- Creation of a discussion network on the Human Security Index that includes workshop participants;
- Development of a roadmap;
- Preparation of guidelines on index compilation methodology;
- Organization of a meeting to select pilot countries;
- Presentation of the Human Security Index to the UN Secretariat.



### Migration and Development: Externalities of the Moroccan Diaspora

Domestically, the Moroccan diaspora contributes significantly to Morocco's economic development. Moroccan migrants alleviate the country's chronic unemployment and underemployment problems, transfer remittances, invest in the homeland, and often visit Morocco as tourists. Furthermore, migrants generally maintain close ties to Morocco and indirectly facilitate third-party trade and investment links between Morocco and host countries. In a Policy Brief entitled "The Moroccan Diaspora and Public Policy" Mahmoud Arbouch and Uri Dadush examine the drivers of Moroccan migration and the many ways in which the diaspora impacts the economy. The authors also discuss ways in which Moroccan policymakers can better capitalize on this diaspora while minimizing the negative effects of having large numbers of migrants abroad.

### Women and the Labor Market: Struggles for Women's Emancipation

In a Policy Brief, entitled "At the Origins of the Women's Question in Morocco, a Reading of Intellectual Debates" Senior Fellow Larabi Jaïdi focuses on the history of feminist movements in Morocco, explaining that the social status of women is the result of a maturation process mirroring political evolution and transformation of the country's family and community structures, over extended periods of time. However, despite efforts to empower women, women's share of the labor market remains remarkably low, not only in Morocco but also in many African and Arab countries. In a Research Paper entitled: "Trade & Women's Wage Employment" Senior Fellow Mina Baliamoune-Lutz examines the impact of trade liberalization on women's access to paid employment in the non-agricultural sector. She argues that trade has varying effects on women's participation in paid employment and that these effects are generally non-linear. Hence, according to Baliamoune-Lutz, it is interesting to note that findings seem to be consistent with a broader "gender equality paradox across the MENA region".

# **INTERNATIONAL** RELATIONS

The international agenda was disrupted severely in 2020 because of the uncertainty caused by COVID-19. While it marked the 75th anniversary of the United Nations Organization, 2020 also saw a notable decline in multilateralism.

### COVID-19 Program

Our international relations experts worked to understand the readjustment of international relations in light of the health crisis. They provided us with their analyses of the impact of a pandemic that has not been constrained by borders.

### A World Without Solidarity

In the face of the enormous political and socio-economic challenges brought about by the pandemic, a number of countries chose the path of nationalism and isolationism, to the detriment of international cooperation and solidarity. Setbacks both in securing genuine international support for the U.N. Secretary-General's call for a global ceasefire, and on negotiations on debt relief for developing countries, were key indicators of the propensity of a growing number of countries to act outside multilateral frameworks.

### A Fragmented Multilateral Order in the Face of the Pandemic

As the world faced its most severe public health crisis of the past century, power rivalries continued to undermine international coordination and cooperation. The lack of an effective multilateral approach was indicative of the strong sovereignist trend observed in a number of countries over the past year. Policy Center for the New South Senior Fellow **Mohammed Loulichki** noted in a Policy Paper entitled "The U.N. at 75: Renaissance or Decadence?" what he described as a disturbing setback for multilateralism and a creeping undermining of its most representative institutions in the current crisis. He outlined several obstacles hindering reform of the U.N. framework.



Policy Center for the New South researcher Salma Daoudi explored the geopolitical stakes in the race for a COVID-19 vaccine in a Policy Brief entitled "Vaccine Nationalism in the Age of COVID-19: Holding back pandemic control". The paper highlighted the adverse repercussions of vaccine nationalism on global power relations, and identified avenues for reflection on facilitating equitable access to vaccines.

Discussions on the future framework of the Africa-Europe partnership came to a complete standstill because of COVID-19. The pandemic brought to light the need to rewrite the narrative on the partnership and to redefine its objectives. **Nezha Alaoui M'Hammdi, Larabi Jaïdi** and **Ivan Martin**, Senior Fellows at the Policy Center, in a Policy Paper entitled "The Africa-Europe Partnership: What Renewal Post COVID-19?" reviewed strategic issues at the heart of Euro-African relations and suggested avenues for reflection on the renewal of the partnership strategy.

A heated clash between China and the United States also marked 2020. The politicization of the pandemic by both powers translated into the weakening of the World Health Organization (WHO), and the withdrawal of its largest contributor amid a health emergency. In a Policy Brief entitled "Sino-American Rivalry: COVID-19 - brake or amplifier depending on player behavior", Policy Center for the New South Senior Fellow Abdelhak Bassou explored the outlook for Sino-American rivalry and the amplifying role played by the health crisis in the confrontation.




# Peace and Security in Africa

Set under an "Africa without conflicts" theme, 2020 sadly saw a heightened terrorist threat and with the entrenching of a number of armed conflicts across the continent. The deteriorating security situation in the Sahel over the past twelve months, and the emergence of new pockets of tension in other sub-regions, have seriously undermined peace and security on the continent.

In a chapter of the "Annual Report on the Geopolitics of Africa" entitled "Security challenges in the Sahelo-Sahelian zone: the challenge of aligning and coordinating national and international responses", Policy Center for the New South researcher Youssef Tobi examined the "Development-Security" paradigm as an approach to curbing the terrorist threat in the Sahel over the long term.



The dispute over the Great Renaissance Dam continues to strain relations between Ethiopia and its northern neighbors. In a Policy Brief entitled "The Egyptian and Ethiopian perspectives on the Grand Ethiopian Renaissance Dam" Sara Hasnaa Mokaddem and Nihal El Mquirmi crossreferenced Egyptian and Ethiopian perspectives on this dispute, which poses a major threat to the stability of the sub-region.




In a Policy Paper entitled "The Climate Change-Security Nexus: Case-Study of the Lake Chad Basin," Maha Skah and Rida Lyammouri reviewed the literature on ties between climate change and security risks, examined changes in policy discourse, and introduced a case study from the Chad Basin to demonstrate how climate change interacts with a variety of other factors (including governance, poverty, and migration) to exacerbate insecurity in the region.

### Increased Activism by Outside Powers

Consistent with recent momentum, Africa continued in 2020 to be an arena for political, economic, and military power struggles. Competition between "traditional" and emerging powers to advance their influence in Africa can be seen in substantial economic partnerships and in occasionally destabilizing security and military involvement in a number of conflict zones. The Policy Center published a number of papers analyzing the different manifestations of this competition and its impact on African countries. Policy Center for the New South Senior Fellow **Hisham Aidi**, in a Policy Brief entitled "Geo-Politics in the Horn of Africa", examined the implications of the competition in the Horn of Africa between Turkey and Iran on the one hand, and China, the United States and Russia on the other, noting intertwining business interests and ideological and security considerations in this "Grand Game" for influence.

The United Arab Emirates (UAE) also stood out as a major player in the geopolitical reconfiguration of the Horn of Africa. Policy Center Senior Fellow **Jamal Machrouh**, in a Policy Brief entitled "The Strategic Extension of the United Arab Emirates: Determinants, Objectives and some Implications for the Horn of Africa," decoded the UAE's sustained diplomatic and military activism. He examined the main objectives of this outreach strategy, including the rivalry within the Gulf Cooperation Council, the confrontation with Iran, and Tehran's flexing of its maritime muscle. The diplomatic offensive recently initiated by Russia seeking to return to the international scene, culminating in the first Russia-Africa summit at the end of 2019, is an important indicator of the powers' growing interest in the continent. As coauthor of the Policy Brief "Russian Interference in Africa: Disinformation and Mercenaries", **Rida Lyammouri** focused on the different strategies used by Russia to project influence and to differentiate itself from rival powers, in particular by detailing the hybrid aspect of this projection of influence and the unofficial nature of Russia's involvement in numerous conflict theaters throughout the continent.





In another Policy Paper, published in collaboration with the Atlantic Council, entitled "Emerging Powers in Africa: Key Drivers, Differing Interests, and Future Perspectives," Maha Skah, Rida Lyammouri, and Khalid Chegraoui analyzed the international politics and power struggles of emerging powers that are attempting to gain ground in Africa.

In 2020, the Policy Center was mentioned in over 1,200 times in both the national and international press. Our publications were cited in leading international media including Forbes, Jeune Afrique, Aljazeera, L'Obs, and in national media including l'Economiste, Telquel, and Medias24. Our researchers appeared in TV programs on international channels CNN International and BFM Business, and domestic channels Medi1TV and 2M. Our experts also collaborated with international radio stations France Culture, RFI and Radio Canada, as well as national stations SNRT, Atlantic Radio and Luxe Radio.

# ATLANTIC DIALOGUES **EMERGING LEADERS**

### INTRODUCTION

The Policy Center for the New South fosters intergenerational dialogue and believes in young people as key agents of change and effective decision-making stakeholders.

The Atlantic Dialogues Emerging Leaders (ADELs) program aims to inspire and energize international dialogue and cooperation, and to build bridges between cultures, regions, sectors, and generations. The Policy Center intends to position Atlantic Dialogues Emerging Leaders (ADELs) as current and future leaders.

Program laureates form an active community-a network of emerging leaders from across the Atlantic region and Africa. The Policy Center has so far established a community of 350 program laureates from over 60 countries and diverse backgrounds. These young leaders remain connected to each other and to the Policy Center's activities through research, conference presentations, and high social-impact projects backed by the Policy Center.

With this community, the Policy Center contributes to intergenerational dialogue and to carving out spaces to support exchanges of this type.

Because of COVID-19, the Policy Center for the New South was unable to organize an annual program in 2020, and instead focused on ADEL community activities and the creation of intergenerational spaces and dialogues.

### **COVID-19 Program**

The ADEL community took part in the COVID-19 research program along with Policy Center staff and experts, through written contributions and participation in webinars and videos developed as part of the program. Program laureates wrote op-eds on topics ranging from the effects of COVID-19 on gender inequality to misinformation, the impact of the virus on development in Kenya, the effects of the pandemic on SMEs and the impact of the pandemic on tourism. Alumni also contributed to short videos produced by the Policy Center on new digital development opportunities and the effects of COVID-19 on economic and social matters. The webinar on the role of civil society in the fight against COVID-19, for example, focused on community members and was attended by three Program Alumni: Wadia Ait Hamza, Aleksandra Chmielewska and Ibraheem Sanusi.

### The ADEL Community Always Connected

With the aim of involving young experts in the Policy Center's debates, ADELs took part in a number of conferences and webinars.

First on the set of the weekly "PCNS Tuesdays" program, specifically to discuss current issues of importance to the Moroccan public, including:

- The effects of COVID-19 on the family | Jihad Bnimoussa;
- Technology in the face of the COVID-19 | Adam Bouhadma;

In June 2020, the Policy Center in partnership with the International Monetary Fund (IMF) held a webinar entitled "Youth and Covid-19: Employment Challenges in North Africa". Significantly, the session was moderated by young ADEL laureate Touria Benlafgih, representing young people in the debate.

### Atlantic Dialogues Emerging Leaders 2019: Program Report

In 2020, for the first time, the Policy Center issued a report covering all key highlights of the previous year's ADEL Program. This report, published in May 2020, is a reference document encompassing different expert and moderator-led sessions that helped promote fruitful discussions in a spirit of sharing with the ADEL 2019 group.

The 2019 edition of the Atlantic Dialogues Emerging Leaders (ADEL) Program hosted 50 young people from over 27 countries of the Atlantic area and Africa. In this edition, the Policy Center held sessions that engaged ADELs in reflection on the state of the world, differing narratives and realities, the power of collective intelligence for policy-making and much more. ADELs also contributed to the production of Program session summaries.

### Atlantic Vision 2025: Building an Atlantic Community - 2<sup>nd</sup> Edition

In December 2019, the Program brought together a group of dynamic young leaders to identify key issues confronting the Atlantic region and how to find common solutions. This report provides a summary of workshop discussions between ADEL 2019 participants. Participants were split into three working groups, each focusing on one aspect of the challenges (economic, political and social) facing the Atlantic region. In the report, published in 2020, ADELs examined two main questions: 1. what are the main issues in the Atlantic basin? 2. What solutions can we find as an Atlantic community?

This exercise prompted participants to take an interest in the future of the region, while exchanging ideas on current issues. It is essential to recall, however, that these issues were discussed in a pre-COVID-19 context. The priorities today are certainly different from what is highlighted in this report.



The Policy Center for the New South and the French Institute for International Relations (IFRI) organized, on February 3 and 4, 2020, the 2nd Edition of the 4x4 Directors Forum: African European Think Tank Dialogue to identify areas of cooperation to build solid bridges between the African and European continent.

Think tanks in the North and the South, Europe and Africa, face similar challenges embedded in different and difficult environments. In the digital age, the links between the African and European

continents will continuously increase, and finding solutions will only be possible through joint effort. As responsible civil society actors are facing similar common challenges in values and fields, think tanks need to affirm their role as the bridges between all stakeholders and provide platforms that encourage dialogue. It is in this spirit that the 4x4 Directors Forum came to be, as the Policy Center for the New South (PCNS) and the French Institute of International Relations (IFRI) decided to organize a conversation between 4 African and 4 European Think Tank directors.

The 4x4 Directors Forum took place in Paris and hosted the following sessions:

- Future Challenges of EU-Africa Relations
- **Power Shifts and Global Trade**
- **Democratic Aspirations**
- Security challenges in the Sahel-Saharan Strip

On the sidelines of the Bamako Forum entitled "What Africa by 2040: between memories and futures", the Policy Center for the New South organized two panels. In a first panel entitled "Decentralization and regionalization: a solution for security issues?", experts and researchers highlighted the importance of regionalization as a tool for managing security challenges in Africa.

The Policy Center for the New South partnered with the Atlantic Council Africa Center on a pair of reports exploring the evolving roles of both traditional and emerging external powers in Africa in the post-COVID era. In its report, Emerging Powers in Africa: Key Drivers, Differing Interests, and Future Perspectives, the PCNS outlines how emerging powers are muscling their way into African markets, crowding a region already beset with security challenges. The complementary Africa Center report, African Agency in the New Cold War: Traditional Power Competition in the Post-COVID-19 African Landscape, focuses on Africa's traditional external powers breaking down the economic and security flash-points that a "new Cold War" could precipitate, while noting with optimism the significant room for African agency even in sensitive fields like Chinese debt and global tech competition.

In this framework, the Policy Center for the New South, in partnership with the Atlantic Council Africa Center, organized on December 14 and 16 two regionally-focused launch events. The first session focused on the Horn of Africa and Red Sea, where conflict in the Tigray region of Ethiopia is winding down alongside a pre-existing scramble for economic and security influence. The second session featured a discussion of the Sahel, where a US draw-down is rumored despite an uptick in violence.

The Policy Center for the New South, in partnership with the International Monetary Fund (IMF), organized a webinar under the theme "Youth and COVID-19: The challenges of employment in North Africa". The current pandemic is having an unprecedented impact on society which remains difficult to fully assess. However, economic recession in many countries is inevitable and hits the most vulnerable. The ILO predicts that young people would be most likely to feel the social and economic impact of the pandemic. A number of questions naturally find their place in the public debate. In this context, the discussions were structured according to two angles of analysis:

- 1. Identify the social and economic impacts of COVID-19 on youth in North Africa;
- 2. Identify the reforms to be undertaken, particularly in the employment and education sectors.

The Policy Center for the New South, the Middle East Institute and the Regional Program Political Dialogue South Mediterranean of the Konrad Adenauer Foundation hosted a joint panel to discuss internal divisions within Libya's civil society and how political institutions have also played a fundamental role in destabilizing the country since the fall of Muammar Gaddafi in 2012.

Governance in Libya is fragmented with very few truly national actors. It also continues to lack political institutions that are seen by all Libyans as legitimate. The ongoing conflict consists of many contending local and tribal players, including spoilers who have demonstrated opposition to either peace or reconciliation except on the basis of total victory by their group.

The following questions were discussed

- What are the major obstacles to stabilization?
- How can Libya approach the establishment of political institutions?
- In what ways can the international community support a Libyan-led peace process?

## MOROCCO **EMPLOYMENT LAB**

J-PAL and Evidence for Policy Design (EPoD) at the Harvard Kennedy School are partnering with the Millennium Challenge Account (MCA) Morocco to launch a two-year "Employment Lab" in Morocco. Hosted by the Policy Center for the New South, this initiative aims to bolster national capacities in assessing and utilizing the best scientific evidence and data for the development and implementation of Evidence-Based employment and labor market policy. The goal is to enhance effectiveness and impact and to address labor market job creation and retention challenges.

Studies conducted by research teams in collaboration with Moroccan partners favor knowledge transfer, sharing, and learning by national institutions. The studies focus on national institutional partners, experts, and professionals' capacity building in the production and application of evidence in developing and implementing public employment and labor market policies. Ultimately, it is about the dissemination and sharing of knowledge, research results and relevant intelligence on employment and labor market policies to stakeholders.

### The laboratory approach to employment

The Employment Lab will work on four complementary components to drive towards creating an evidencebased policy culture and ensure that labor market programs are supported by evidence:

- 1. knowledge gaps.
- 2. design.

Identifying policy priorities: The Employment Laboratory will work with policy makers to identify key policy challenges - particularly those exacerbated by COVID-19 - as well as identifying and prioritizing

Building evidence utilization capacity: The Employment Laboratory will organize training workshops and events on generating and using evidence in policy development. Customized training will be successively provided to researchers, public service trainees, NGOs and government officials at different levels to build a broad understanding on how evidence can be used in policy and program

Conducting impact evaluations: The Employment Lab, in collaboration with policy partners, will design and implement a set of rigorous impact evaluations that address identified policy priorities.

Sharing evidence to inform policy: The Employment Lab will disseminate research findings to a wide range of stakeholders through a large-scale policy symposium, briefing notes, and online


